NEW Safeguarding Website in Worcestershire Launches 20th May 2019

As previously reported in Safeguarding Matters, Worcestershire Safeguarding Children Board and Worcestershire Safeguarding Adults Board have joined forces to commission a joint safeguarding website. Work has been taking place to develop the site and is now nearing completion. The new website will provide access to safeguarding information for local practitioners, agencies and members of the public. The Inter-agency Child Protection Procedures are unaltered and will remain available through the existing West Midlands Procedures site. They will also be easy to access from the new website.

The go live date for the site is May 20th 2019 the web address of the new site will be www.safeguardingworcestershire.org.uk.

WSCB Transition to Worcestershire Safeguarding Children Partnership

As reported in the January newsletter work is now in progress to transition from Worcestershire Safeguarding Children Board (WSCB) to Worcestershire Safeguarding Children Partnership (WSCP).

The new arrangements will be published by 29th June and full transition will be implemented by 29th September, 2019. WSCP has been developed to comply with the statutory guidance 'Working Together to Safeguard Children 2018'.

The principles of this design are as follows:

- Maintain independence of the partnership board chair to bring cross partnership scrutiny and challenge to the way we work together
- Streamlining of sub groups and functions to reduce bureaucracy and focus on priority issues
- Maintain fullest possible membership of partners outside the three named safeguarding partners (Local Authority, Clinical Commissioning Groups & Police)
- Deliver a coordinated Quality Assurance and Learning & Development programme

The purpose of the new partnership approach is to evaluate the effectiveness of safeguarding children and young people through:

- Agency collaborations to share and co-own the vision for how to achieve improved outcomes for vulnerable children
- Challenge appropriately and hold one another to account for the effectiveness of early identification and multi-agency response to safeguarding
- Commitment to deliver and evaluate the Quality Assurance and Learning and Development programmes to promote and embed best practice in the way local services for children and families are delivered
- Review and evaluate effectiveness of front line multi agency practice in relation to high quality and timely decision making, assessment and planning to protect children from harm

The final edition of Safeguarding Matters (WSCB newsletter) to be produced in July 2019 will contain further information about the new safeguarding partnership arrangements, including how safeguarding issues will be communicated to frontline practitioners going forward.

*** Multi agency training – changes from September, 2019 ***

WSCP will develop a programme of multi-agency events which focus on how agencies work collaboratively to produce the best outcomes for children and young people. The details of new multi-agency learning events will be available in due course. In order to create the capacity to deliver a new Learning & Development programme the new Safeguarding Partnership will not be delivering the current multi agency core safeguarding training courses (Target 1, 2 and T2 refresher) after July 2019.

Worcestershire Children First

In September 2017, following a report from the Worcestershire Children's Commissioner, the Department for Education directed that Worcestershire County Council should move the operational delivery of Social Care Services for Children to an Alternative Delivery Model.

This meant the Council would no longer have the responsibility of operationally delivering the services it currently provides and would voluntarily move to an alternative way of delivering these services.

Worcestershire County Council had completed a review earlier in 2017 with the aim of Introducing a new way of delivering Children's Social Care services; to help accelerate and sustain improvements in Children's Social Care.

The alternative way of delivering these services would allow more focus on improving services and keeping children and young people safe from harm.

Alongside the commitment and determination to improve the lives of children and young people in Worcestershire, this approach supported opportunities to make services better, more secure and effective in the future.

Worcestershire County Council's Cabinet met on 29 March 2018 and approved recommendations for the development of a Wholly Owned Council Company as the alternative delivery model to deliver Children's Social Care.

The new company, called Worcestershire Children First, would be a 'not for profit' company and 100% owned by Worcestershire County Council. It will be operationally independent and have a single focus on children and young people; however strategic objectives and significant decisions will remain with the Council.

On 14 March 2019, Cabinet approved the size and scope of the company meaning that Worcestershire Children First would also be responsible for delivering education and early help services. Also approved was the recommendation not to extend the contract with Babcock Prime beyond October 2020. The Director of Children's Services has been authorised to work with Babcock Prime and the education sector to initiate the exit planning and transfer arrangements for services to transfer into Worcestershire Children First at the earliest opportunity.

One of the key benefits of the Company having a broader scope of services is that it will strengthen the focus on improving outcomes for all children and young people in Worcestershire. It will also have the opportunity to redesign services and integrate more closely to achieve its priorities. This will enable children, young people and families to feel valued, heard, and ensure staff are responsive to their needs across a variety of services within the system.

Worcestershire Children First will be operationally independent and governed by its own Board however, as a wholly owned council company, a number of strategic objectives and significant decisions (reserved matters) will remain with the Council.

The Worcestershire Children First Board will comprise of 11 Board Members including a Chair (appointed by the Department for Education whilst the Council remains in intervention), four Executive Directors including the Chief Executive; three Council appointed Members (two Councillors, one Officer) and three independently appointed non-executive directors.

The Company has now entered its phased shadow period. During this period the Company Board will begin to work together in preparation of the official launch on 1 October. It also gives an opportunity to 'test and learn' ways of working and day-to-day operations and allow time to review amended roles and responsibilities and monitor and maintain business-as-usual as much as possible.

Signs of Safety **Update**



In October 2017 Worcestershire County Council began training Children's Social Care staff in the Signs of Safety Practice Model. Since that time they have trained 600 practitioners and team managers in the approach. In October 2018 they launched a specific set of 1-day training events for partners and have trained just over 200 safeguarding leads in the approach. The feedback from partners who attended the training revealed:

- 98% knowledge increase in the Signs of Safety Approach
- 93% confidence increase in the Signs of Safety Approach

Feedback from professionals and families has been positive in respect of the approach which enables families to understand why agencies are concerned about their children, the family's strengths and what the family need to do to keep their children safe.

Changes to GCSX secure email in County Council

From 31 March 2019 Worcestershire Council staff will not be using GCSX to send secure emails. Instead staff will be using their standard @worcestershire.gov.uk account. The Council's IT team have ensured that all WCC generic emails are secure and therefore after 31 March @worcestershire.gcsx.gov.uk email addresses will no longer work and emails will not be forwarded. If you have been sending information through to County Council staff using GCSX please contact them to confirm new arrangements.

Changes To Contact Details For Local Authority Designated Officer (LADO)

All organisations providing services to children and young people must ensure that their staff and volunteers are safe to do so. Most adults who work with children and young people act professionally and provide a safe environment for the children and young people in their care, however, it must be recognised that there are adults who will deliberately seek out, create or exploit opportunities to abuse children.

The allegations' process is managed by <u>Worcestershire's Local Authority Designated</u> <u>Officers (LADO)</u> as part of the Safeguarding and Quality Assurance Service.

From April 2019 the LADO secure email will be through <u>LADO@Worcestershire.gov.uk</u>.
