Network Group

The Adults Safeguarding Network Group met 24th October 2019. This group is open to organisations who directly deliver services to adults at risk, including voluntary sector and services that operate at a district level. The purpose of the group is to share information about Safeguarding and look at how to address issues which don't meet the Section 42 criteria.

Board Update

The last WSAB Board meeting was held in December, whilst the minutes of this will not be published on the WSAB website until they are signed off at the next meeting in March, items discussed include:

- **Police National Guidance – Safeguarding Policy** – This has been developed in conjunction with West Mercia Police and has been adopted nationally. A copy can be found here [Police National Guidance Safeguarding](#)
- **Liberty Protection Safeguards (LPS).** Concerns were raised regarding training which was being provided by some organisations, as the Code of Conduct had not yet been published by the Department of Health and Social Care. The WSAB agreed to issue a statement recommending organisations wait to see what is in the Code of Conduct before they embark on any training. Case Review

Thematic Safeguarding Adults Review on Rough Sleepers

A thematic SAR looking at the experience of Rough Sleepers has now begun, following a stakeholder event held in November. The Independent Author is currently meeting with those organisations who worked with the rough sleepers, alongside wider interest groups.

Communications

Work continues on the development of the new website.

At the last meeting one of the topics discussed was on financial scams, in particular those where vulnerable adults are targeted and significant amounts of money are removed from their bank accounts. Regulatory Services, one of the WSAB stakeholders, have been involved in a number of initiatives to raise awareness amongst the public and Banks. Performance & Quality Assurance

As part of their work this sub-group is monitoring the progress of multi-agency actions associated with Safeguarding Adult Reviews (SARs) and have now developed an audit programme.

The first audit examined the application of Making Safeguarding Personal (MSP) when Safeguarding concerns are reported. 50 randomly selected 'cause for concern' notifications were audited to see if the following criteria had been applied and understood by the practitioner:

- The adult will have consented or there is valid justification for why they did not;
- It is clear what outcome the adult wants from Social Work involvement;
- The concern and level of risk are clearly expressed

Whilst there was evidence of good and effective practice, the audit findings suggested that there was still a need to embed MSP into practice and a number of recommendations were made. It has been agreed a further review will take place in a year to assess the impact of these actions and ongoing work.

Making Safeguarding Personal
